

ORDINANCE NO. 43-2018

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY AUTHORIZING THE REPLACEMENT OF 23 GARAGE DOORS AT THE DEPARTMENT OF PUBLIC WORKS BUILDING LOCATED AT 25 NORTH JEFFERSON ROAD IN THE WHIPPANY SECTION OF THE TOWNSHIP AND FURTHER APPROPRIATING THE SUM OF \$50,000.00 FROM THE TOWNSHIP'S 2018 CURRENT FUND BUDGET FOR THE FINANCING OF THE PROJECT

WHEREAS, the garage section of the Department of Public Works, Buildings and Ground and Park Maintenance Building is used for the storage and repair of vehicles and equipment; and

WHEREAS, the garage doors are heavily used throughout the year; and

WHEREAS, due to use and exposure to the elements, the garage doors are in disrepair and have outlived their useful purpose; and

WHEREAS, it is the intention of the governing body to authorize the replacement of the doors.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hanover, in the County of Morris and State of New Jersey as follows:

Section 1. The governing body hereby authorizes and approves the replacement of 23 garage doors at the Department of Public Works, Buildings and Ground and Park Maintenance Building located at 25 North Jefferson Road in Whippany.

Section 2. The Township Engineer and/or the Assistant Township Engineer are authorized and directed to prepare the necessary drawings, plans and specifications for the garage door replacement.

Section 3. In accordance with the drawings, plans and specifications, the Township Engineer and/or Assistant Township Engineer are authorized and directed to advertise for the receipt of sealed competitive bids for the garage door replacement set forth in Section 1. above, all in accordance with the Local Public Contracts Law at N.J.S.A. 40A:11-1 et seq.

Section 4. There is hereby appropriated the sum of \$50,000.00 for the replacement and installation of new garage doors as described in Section 1. of this Ordinance from the following account:

Section 5. All ordinances of the Township of Hanover, which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.


