

ORDINANCE NO. 42-2018

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY AUTHORIZING THE REPLACEMENT AND UPGRADE OF THE AIR CONDITIONING SYSTEM IN THE MULTI-PURPOSE COMMUNICATION ROOM AT THE MUNICIPAL BUILDING AND FURTHER APPROPRIATING THE SUM OF \$25,000.00 FROM THE TOWNSHIP'S 2018 CURRENT FUND BUDGET FOR THE FINANCING OF THE PROJECT

WHEREAS, the existing air conditioning system in the Multi-Purpose Communications Room at the Municipal Building has been experiencing repeated failures and has outlived its useful purpose; and

WHEREAS, the location of the existing air conditioning system has caused damage to nearby telephone and computer equipment in the room; and

WHEREAS, a new type of air conditioning system will need to be installed to eliminate damage to nearby telephone and computer equipment.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hanover, in the County of Morris and State of New Jersey as follows:

Section 1. The governing body hereby authorizes and approves the replacement of the existing air conditioning system in the Multi-Purpose Communications Room at the Municipal Building with an upgraded air conditioning system.

Section 2. The Township Engineer and/or the Assistant Township Engineer are authorized and directed to retain the services of a licensed professional engineer in order to prepare the necessary drawings, plans and specifications for the replacement and upgrade of the Multi-Purpose Communications Room air conditioning system.

Section 3. In accordance with the drawings, plans and specifications, prepared by the licensed engineer, the Township Engineer and/or Assistant Township Engineer are authorized and directed to advertise for the receipt of sealed competitive bids for the improvements set forth in Section 1. above, all in accordance with the Local Public Contracts Law at N.J.S.A. 40A:11-1 et seq.

Section 4. There is hereby appropriated the sum of \$25,000.00 to furnish and install the improvements as described in Section 1. of this Ordinance from the following account:

Section 5. All ordinances of the Township of Hanover, which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.


