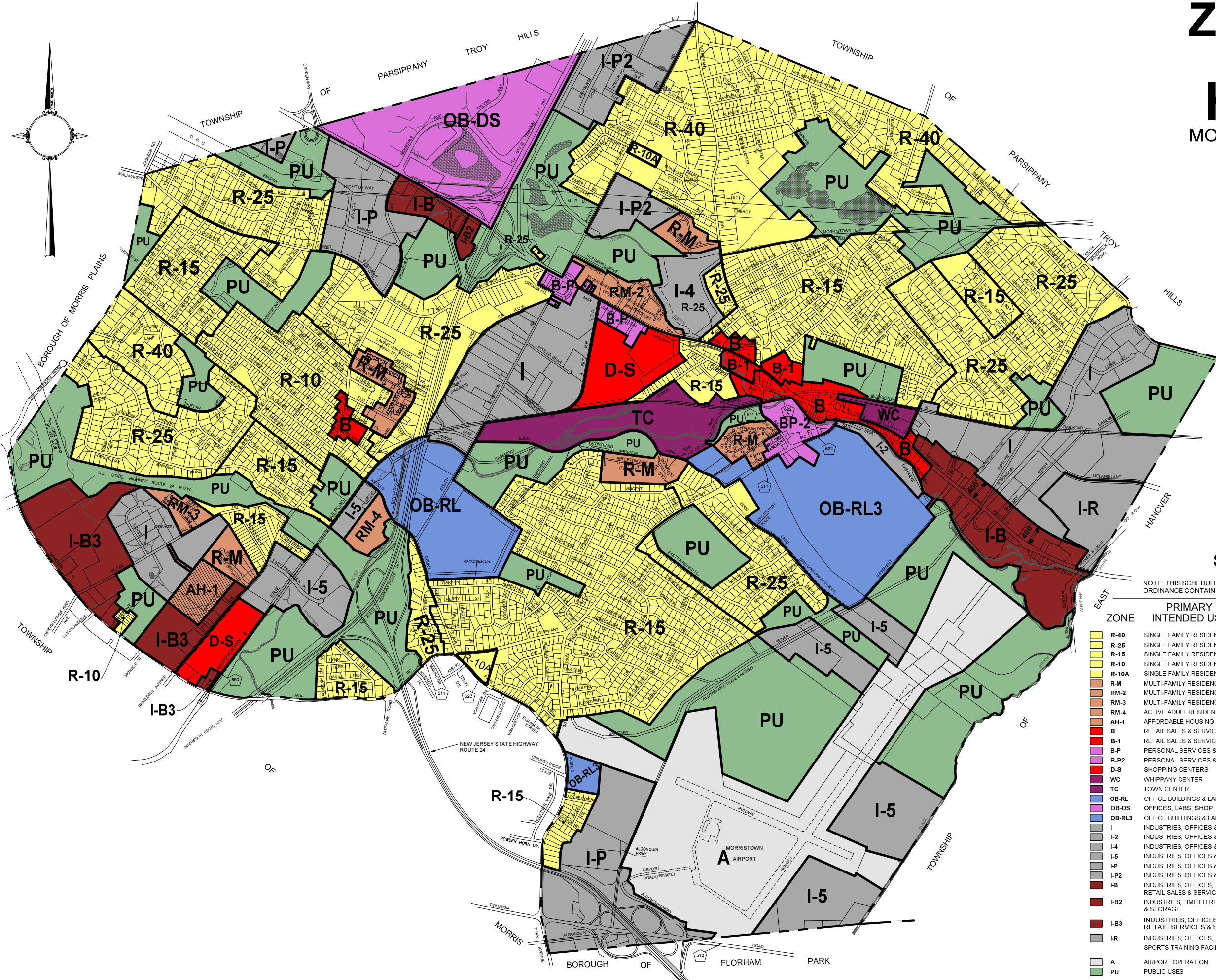
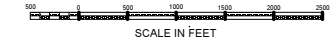


ZONING MAP
