Some 50 have been handed out. The next 100 will be placed in various venues in the next few weeks.

The work is awaiting Vivian's April return (she is bringing us all some sand.)

- iii. Education & Community Involvement: Tours & Volunteers
  - 1. Possibly, a tour on Sunday, September 21st.
  - 2. We are looking for appropriate projects for the Scouts. They may be able to clean the tombstones wearing masks and gloves.
