PRESENTATIONS:

RECOGNITION OF SERVICE AS A MEMBER OF THE BOARD OF RECREATION COMMISSIONERS – ARLENE YANNOTTA

The Township Committee presented a mantel clock to Arlene Yannotta upon her retirement in recognition of having served as a Commissioner for the past 29+ years.

TWO-WAY POLICE RADIOS FOR SECURITY PURPOSES TO HANOVER TOWNSHIP SCHOOL DISTRICT SUPERINTENDENT SCOTT PEPPER AND HANOVER PARK REGIONAL HIGH SCHOOL DISTRICT SUPERINTENDENT CAROL GROSSI

Mayor Francioli, on behalf of the Township Committee, presented retired twoway police radios to School District Superintendent Scott Pepper and Whippany Park High School Principal John Manning of the Hanover Park Regional High School District. Whippany Park Resource Officer Mike Murphy and several Board of Education members were also in attendance.

Mayor Francioli explained that the 10 donated police radios will be used in the schools for emergencies. A call can be put out directly to nearby patrol cars which would cut down on response time.

OPEN TO THE PUBLIC:

Mayor Francioli opened the meeting to the public.

Several residents addressed the governing body and urged the members of the Township Committee to vote no this evening on introduction of Ordinance Nos. 17-13 and 18-13. Ordinance No. 17-13 will change the zone classification of property located at 62-66 North Jefferson Road from the R-40 zone district to a new R-10A zone district; and Ordinance No. 18-13 will change the zone classification for Lots 4 and 5 in Block 2902, located at the intersection of Jefferson Road and Route 10, from the R-25 zone to the B-P zone by adding convenience stores and motor vehicle service stations.

The following residents commented:

- 1. Joe Mihalko of 12 Anna Terrance opposed to Ordinance No. 17 which he described as a compromise in favor of developer Joseph Forgione.
- Former Mayor Len Fariello opposed to both Ordinances Nos. 17 and 18.
 He felt Ordinance No. 17 would be of no benefit to the Township and that
 Ordinance No. 18 would allow a Quick Chek to be added to an already
 dangerous and failed intersection.
- 3. Carol Fomchenko of 38 Malapardis Road opposed to Ordinance No. 18 which she described as being created to adapt to a developer's needs.
- 4. Father Roman, Pastor of St. John's Ukrainian Church opposed to portions of the proposed concept plan submitted in connection with Ordinance No. 17 and requesting that the zone reclassification of Ordinance No. 18 be extended to the church property also located at the Jefferson Road / Route 10 intersection.
- 5. Resident Michael Mihalko opposed to Ordinance No. 17. He questioned what the benefits were to the town to allow 16 condo units to be constructed at the Jefferson Road Location.
- 6. Joe Shatynski of 40 Windemere opposed to Ordinance No. 17 and the density it allows. He also advised that he has no confidence in the Planning Board. After attending a recent Board meeting he said he finds their actions

shocking and disrespectful.

- 7. Diane Murray of 2 Hilltop Circle opposed to Ordinance No. 17 which she feels would add to the school population and increase class sizes.
- 8. Ed Moscariello of 27 Malapardis Road opposed to Ordinance No. 17 and the density it allows. He noted that after approving the Windemere cluster the Planning Board vowed it would never again approve anything with that density. He also opposed Ordinance No. 18 due to several safety issues, one of which would be youngsters playing sports at Veterans Field crossing Route 10 to get to the Quick Chek.
- 9. Resident Andie Mihalko opposed to Ordinance No. 17. She pointed out that there are other developers who would be interested in developing the site without the need of a zone change.

Mayor Francioli defended the actions of the Planning Board and noted that resident concerns will be addressed by the Planning Board following the submission of formal applications by the developers of both sites.

Ms. Uibelhoer of 15 Crestview Terrace then addressed the Township Committee to request relief from the requirements and/or a reduction of fees as required by the Tree Ordinance.

Mayor Francioli stated that the request would be submitted and reviewed by the Township's Planner and the Township Engineer.

No further comments forthcoming, Member Brueno moved the public hearing be declared closed. The motion was seconded by Member Schleifer and was unanimously passed.

OTHER BUSINESS:

Member Brueno announced that the summer concerts, sponsored by the Parks & Recreation Department, will take place at Brickyard Field on Monday evenings in July at 7PM. He also announced that the July4th fireworks will take place on July2nd from 6-8 PM.

Member Coppola once again announced that police officers will be present at polling places for the 2013 special elections and for the general election. With regard to alternate polling places, he advised that it is anticipated that changes will occur in 2014 as changes require County Board of Election approval.

JCC Affordable Housing Site – the application has been rejected by the Township for lack of funding, therefore, the application has been withdrawn.

South Campus – an extended stay hotel with conference rooms has expressed an interest.

Care One – consideration is being given to an additional facility which specializes in rehabilitation and assisted living.

High End Condo Market Units – consideration is being given to perhaps 120 rentals, which rentals are needed by Bayer HealthCare and the community.

River Park – Plans are being submitted to the Township for flex buildings – the dam will be removed which will require reconfiguration of the Whippany River.

Connectivity – the Township has executed a contract with a consulting firm for the preparation of a plan for bicycle, jogging, walking paths / trails which will connect all the segments of Patriots Path that are owned by the Township to create a connected trail.

OPEN TO THE PUBLIC:

Mayor Francioli opened the meeting to the public.

School Superintendent Scott Pepper expressed his appreciation to the Township Committee for donating the two-way radios. In addition, he thanked Member Schleifer for donating a drum set and a guitar to the school.

Joe Mihalko again addressed the governing body quipping that the items donated by Member Schleifer were given to him by his godmother 40 years ago and were never used.

Mr. Mihalko also mentioned several other items that concerned him. He requested that something be done about providing sidewalk on Reynolds Avenue and Parsippany Road. With regard to the new Quick Chek on Parsippany/Whippany Road, he felt that the left hand exit turn should be prohibited as motorists are crossing four lanes of traffic.

Following several other comments by residents who spoke earlier this evening, Member Bruno moved the public hearing be declared closed. The motion was seconded by Member Coppola and was unanimously passed.
