This young man has come to see and fulfill obligation for Boy Scouts a Civic and Community Merit Badge and it's such a shame that the only one you get to address tonight are our guest, the video recorder and myself, a sad commentary from this Town and I'm distressed about that but I get distressed easily.

I noticed that in tonight's agenda in particular 28-2014 an ordinance to vacate Dennis Avenue, is going to be carried over until July is that correct?

Mr. Giorgio: That is correct.

Mr. Mihalko: My only question on that particular issue is what predicates a vacating or maintaining a paper street?

Mayor: This is with an association with the home owner who is using that corner property and there is an access issue as well; my facts on this Joe, particular homeowner who owned a piece of property contiguous with this paper street and is now going to develop this property, build a home, and the street becomes, to him, a critical access point for frontage on a street. Gerry I think you have more facts than I on why we asked to vacate the street.

Mr. Maceira: To answer your question, we are analyzing whether that street is needed. I guess that street was put there in the past and they thought there was a need to develop that property. When this homeowner requested that this portion of Dennis Avenue be vacated we analyzed whether there is a need to maintain that, and not only Engineering Department myself we reviewed it with Zoning, Planning, Emergency Officials, whether there is ever a need for that road, when we determined there is no need for that portion of that road, then the Ordinance is proffered.

Mr. Mihalko: So it would essentially be a petition by the owner of that property?

Mr. Maceira: In that particular case, yes it was.

Mr. Mihalko: Okay fine, just point of reference for my own benefit.

The last comment I am going to make and I'm sure some of you have to breathe a sigh of relief; the last few months rumors have certainly bound in a small town like ours, we all know that we hear things and see things I would just like to remind this august body the intent of the residents of Hanover Township in electing you to our Township Committee is that you put forward the best interests of Hanover Township before the pocket book of developers.

Mayor: Joe I would say that that is an understatement. That each individual hear regardless of our own personal sentiments and I try to remind them and I do remind them that they represent a constituency of this Township and not themselves. They are not a constituency of one they are a constituency of this Township, and while

we have developers in this Township are coming forward and John hears me on the Planning Board on this with all plans that are subject what the current markets are in this town, and if the markers are office buildings as they were in the 1980's every developer in town that came before the Planning Board wanted office buildings and now it seems that the trend is for now rental units. Housing stats are still low but the rentals seem to be the market. Market's don't drive good zoning developers don't drive good zoning, Planning Board has to represent people of their Township that is what everyone that sits there as you know is a member of the Township, they make decisions that are right not for today, but for 10 years from now and 20 years from now when somebody takes over these seats. So this team feels that way, I think so. Thank you Joe.

WHEREAS, as part of its philosophy to strengthen the ties between the corporate community and attract new commercial businesses and retain existing businesses in Hanover Township, the governing body has created the position of Community Affairs/Public Policy Coordinator which duties and responsibilities will be assigned and performed by the Township's Assistant Business Administrator; and

WHEREAS, it is the intention of the governing body to amend and supplement Section 3. Of Ordinance No. 23-2014 with the inclusion of the title for the new position of "Community Affairs/Public Policy Coordinator" and remuneration in the form of a stipend.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

Section 1. Section 3. Of Ordinance No. 23-2014 is hereby amended and supplemented with the inclusion of the following title and stipend for the position of:

"7. Community Affairs/Public Policy Coordinator.....\$3,500.00."

Section 2. All ordinances of the Township of Hanover which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

ORDINANCE NO. 33-14

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE
TOWNSHIP OF HANOVER AMENDING AND SUPPLEMENTING
SECTION 248-20. ENTITLED "MAINTENANCE AND REPAIR
SPECIFICATIONS." AND SECTION 248-22. ENTITLED "PROTECTION
OF VEHICULAR AND PEDESTRIAN TRAFFIC; SAFE WORKING
CONDITIONS". UNDER ARTICLE II, "STREET OPENINGS" AS SET
FORTH UNDER CHAPTER 248 OF THE OF THE CODE OF THE
TOWNSHIP OF HANOVER ENTITLED STREETS AND SIDEWALKS,
TO REQUIRE ROAD RESTORATION AND CONSTRUCTION SIGNS
FOR ROADWAY WORK CONTRACTORS**

WHEREAS, there is in existence a "Road Opening Ordinance of the Township of Hanover."; and

WHEREAS, pursuant to that ordinance, a person, firm, corporation or municipal or public utility may apply with the Township for a permit to perform roadwork on roads under the control of the Township; and

WHEREAS, it is important for the safety of the Township's residents and those traveling in the Township that there be an adequate posting of the roadwork; and

WHEREAS, the Township desires to make those persons and/or entities performing road opening work responsible for restoring the road to its original condition;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Hanover, in the County of Morris and State of New Jersey, as follows:

Section 1. Section 248-20. And Section 248-22. under Chapter 248 of the Code of the Township entitled Streets and Sidewalks are hereby amended and supplemented in their entirety to read as follows:

§ 248-20. Maintenance and repair specifications.

Upon completion of the opening and backfill as specified and upon the Township's being notified of the same, the following specifications shall govern the maintenance and repair of street openings by the Township or by the permittee, as the case may be:

- A. Shoulder openings shall be backfilled to within eight inches of the existing shoulder surface. The remainder of the trench shall be filled with six inches of two-and-one-half-inch stone and all voids with stone dust. When authorized, an approved shoulder stone may be used as an alternate for the macadam base. The remainder of the opening over the macadam base will be filled with the shoulder stone and tamped or rolled with equivalent five- to ten-ton roller or an equivalent approved by the Township Engineer. The above trench shall be

maintained and kept to the existing shoulder grade by the addition of shoulder stone as required. Shoulder openings are herein defined as openings within the street, any part of which are adjacent to or within three feet of the existing pavement.

- B. Pavement openings shall be filled and paved as specified hereinabove for shoulder openings, except that, in place of the shoulder stone used to fill in the remainder of the openings, bituminous concrete Type A shall be used. When, in the opinion of the Township Engineer, settlement in the pavement opening has ceased, the bituminous-concrete surface shall be removed, and the existing pavement shall be cut back to a sharp line one foot on each side of the opening. After surfaces of the existing pavement are tack coated with an asphalt oil, the entire area shall then be filled with bituminous concrete Type A or FABC No. 1 and rolled to present an even riding surface. Pavement openings are herein defined as openings within the traveled roadway or between curbs where curbs exist on a street. Pavement openings shall be filled and paved the full width of the entire lane in which the opening occurs.
- C. Driveway openings shall be replaced in kind, and the appropriate specifications for shoulder openings or road openings shall govern the replacement of the same.

§ 248-22. Protection of vehicular and pedestrian traffic; safe working conditions.

- A. It shall be the responsibility of the person, firm, corporation or municipal or public utility opening any thoroughfare, or otherwise endangering or obstructing the normal flow of traffic or normal flow of surface water thereon, to fully protect both vehicular and pedestrian traffic from possible accident or injury by the placing of suitable barriers, crosswalks, notices, warnings and/or caution signs by day and flares and flashing lights at night, in accordance with the provisions of Title 39 of the Revised Statutes of New Jersey, with amendments thereof and supplements thereto. The Chief of Police will determine the adequacy of such protection.
- B. The person, firm, corporation or municipal or public utility opening any thoroughfare, or otherwise endangering or obstructing the normal flow of traffic or normal flow of surface water thereon, must also post a sign stating, "Temporary Construction Work" and including on the sign, the name of the utility and its phone number. The sign may only be removed upon completing the final top course of the roadway.
- C. Any contractor, municipal or public utility, person, firm or corporation performing any street opening and excavation work in, over or upon any public road right-of-way or easement shall be totally responsible in providing safe working conditions for its employees and the public. These conditions include but are not limited to trench safety and confined space entry. The contractor/utility shall comply with all Occupational Safety and Health Administration (OSHA) requirements.

Furthermore, contractor(s) shall comply with all applicable laws, statutes, ordinances and regulations, including, without limitation, all applicable provisions of federal and New Jersey State labor laws. In order to comply with the Township's confined space entry requirements, the contractor/utility must have at a minimum a permit required confined space program in conformance with the requirements of 29CFR1910.146, including but not limited to procedural operations, trained employees and specialized equipment. Township and Authority personnel will not supervise or direct the work of contractor personnel. Observation of the work by Township or Authority personnel is solely to determine the adequacy of construction and is not intended to and shall not include the review of the adequacy of contractor safety measures in, on or near the work site.

Section 2. All ordinances of the Township of Hanover which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 3. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

Section 4. This Ordinance shall take effect in accordance with law.

This Ordinance will be further considered for Public Hearing and Final Passage during the Township Committee Meeting on July 10, 2014 at 8:30 pm and at this time any person wishing to be heard concerning this Ordinance will be given the opportunity to speak.

RESOLUTION NO. 122-2014

A RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER ADJUSTING THE SALARY OF POLICE CHIEF STEPHEN W. GALLAGHER TO \$148,329.00 PER ANNUM IN ACCORDANCE WITH SECTION 7. OF SALARY ORDINANCE NO. 23-2014

WHEREAS, the Township of Hanover and Superior Officers Association Local #128A recently reached agreement on a collective negotiations agreement for the period beginning January 1, 2009 through December 31, 2013; and

WHEREAS, in addition to receiving a wage adjustment for each of the five (5) calendar years, the agreement provides that effective January 1, 2013, the salaries for the rank of lieutenant and captain shall be adjusted so that the salary for lieutenant shall be at a differential of 7.5% above that of a sergeant at top step, and that the salary for captain shall be a differential of 7.5% above that of lieutenant at top step; and

WHEREAS, Salary Ordinance No. 23-2014 adopted by the Township Committee on May 22, 2014 established a salary range of \$125,000.00 to \$148,329.00 per annum for the rank of chief; and

WHEREAS, pursuant to the salary range set forth in Salary Ordinance No. 23-2014, the Chief is being compensated at \$146,783.00; and

WHEREAS, as the highest ranking managerial officer in the Police Department, the salary of the Chief needs to keep pace and be above those rates of compensation established for the ranks of lieutenant and captain; and

WHEREAS, it is the intention of the Township Committee to adjust the salary of the Chief of Police to the maximum amount permitted under Salary Ordinance No. 23-2014.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

1. In accordance with Section 7. Of Salary Ordinance No. 23-2014, the salary of the Chief of Police shall be adjusted from \$146,783.00 to \$148,329.00 per annum upon the approval of this resolution. The Chief shall be entitled to the difference between both salaries retroactive to January 1, 2014 pursuant to Section 15. Of Salary Ordinance No. 23-2014.
2. That certified copies of this resolution shall be transmitted to the Township's Chief Municipal Finance Officer and the Chief of Police for reference and information purposes.

Whippany's own AMA Martial Arts Studio in Pine Plaza has signed up to work with substance awareness council and what is nice about that is since 2011 with John Ferramosca we thought to have a special seminar to our HS seniors that are getting ready to move away to college or move out of their homes; and work with them on situation awareness and some basic street smarts education and some self-defense techniques if they need them one day, well AMA has agreed to work with us they opened up their studio to us and we are talking to the High School about doing a full day in October for every gym class for the Juniors and Senior in Whippany Park High School, I just want to thank them, it's a Hanover Township Business and they will be given us quite a bit for our kids.

Mr. Brueno: Come out and celebrate the patriot in July 4th Fireworks on July 2nd; saving the taxpayers of Hanover substantial amount of money and allowing everyone to view the fireworks some place on the 4th. The wind symphony will be performing a lot of good stuff going on at the high school, fund raisers and so forth. Come out early.

Summer concert series which we have mentioned previously is right around the corner starting the following Monday, July 7th and continued 14, 21, and 28. The 5^{0th} anniversary of Bee Meadow Pool is Friday, July 25 lots going on in the month of July we encourage everyone to come out and take advantage of all of this free activities sponsored by Hanover Township Recreation.

Mr. Coppola: Landmark they have really done a good job working with the tourism group of Morris County, they are really going all out to put the burial yards on the map and that's the first phase. We actually met at the burial yard, a group of us, and decided where the different expansions are going to go, to know where the different people are buried throughout the process, throughout that yard.

Secondly, graduation last night went very well, a little warm in the gym but the Superintendent reminded us about the bad winter we had that it wasn't so bad to have a warm day. I would like to thank the entire committee with the school safety zone and all the work that was put into that they are fully supportive of us and full support the committee and for the children of our community. Thank you very much to the Mayor and the Members, the committee is working very hard.

Member Gallagher: One of our biggest partners in this committee is Trans options, and Andrew called me the other day, he was very happy that the Township Committee appropriated all the money that we asked for with our six month study and to give credit to the Township Committee and everybody working together, he said he has never worked with a town that moved this fast that worked this hard and they are all on the same page and moving towards the same directions. So with what Member Coppola just said I'm going to echo and say how much how much we all worked hard together and said we our subcommittee has seven member but we really have 12 because this entire Township Committee is working with us all the time on it and we also are working with Scott Pepper and many members in the schools. I just wanted to say we got a big compliment.

Mayor: It's an excellent program and fully funded now, and I might say for the Township Committee was pleasantly surprised at the fact that they were not in fact enormous amounts of money to restripe streets and affordable signage that would warn, simple matters of just bringing shrubbery and landscaping back so lines of sight could be better improved for the safety of the children and the programs you put together for the kids, I personally was so fond of the walking program that you had one day. The idea of walking to school wow. You did a great job of heading that up and George on that staff as well as the Police Department!

Certainly, I want to mention that Deputy Mayor Ferramosca that the Red Bulls are expanding their facility they are also expanding their commitment to Hanover Township.
