ORDINANCE INTRODUCTION

ORDINANCE NO. 4-2016

AN ORDINANCE OF THE TOWNSHIP COMMITTEE AMENDING AND SUPPLEMENTING SECTION 125-2. ENTITLED RAFFLE LICENSING FEES AND SECTION 125-4 ENTITLED "RECREATION DEPARTMENT FEES" UNDER CHAPTER 125 OF THE CODE OF THE TOWNSHIP OF HANOVER ENTITLED FEES WITH THE INCLUSION OF NEW RESIDENT AND NON-RESIDENT POOL MEMBERSHIP FEES FOR THE YEAR 2016 BEE MEADOW SWIMMING POOL SEASON AND OTHER RECREATION DEPARTMENT FEES

WHEREAS, a need exists to update the Township's Raffles Licensing Fees to bring them current with the Fee Schedule required by the New Jersey State Legalized Games of Chance Control Commission; and

WHEREAS, in addition, the Board of Recreation Commissioners, in a memorandum dated January 20, 2016 to the Mayor and Township Committee have recommended certain increases in the pool membership fees for the 2016 Bee Meadow Swimming Pool Season as well as amendments to the Recreation Department's facility and picnic fees; and

WHEREAS, the Township Committee has carefully reviewed the recommended fees and concurs that the proposed new rates are reasonable and fair and should be adopted; and

WHEREAS, in accordance with the Commissioner's recommendations, and, its own review, the governing body has decided to amend and supplement Section 125-4. of Chapter 125 of the Code of the Township of Hanover, entitled "Recreation Department Fees", with the inclusion of the Bee Meadow Swimming Pool Membership Fee Schedule which reflect the new pool membership fees for the year 2015 Summer Season.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

Section 1. Section 125-2. Fees Collected Through Clerk's Office is hereby amended and supplemented with the inclusion of new raffle and bingo licensing fees as follows:

A. Raffles:

On Premise Draw Raffles: Awarding cash or merchandise as a prize; \$20.00 for each day for which a drawing is held;

- B. Off Premise Draw Raffles: Awarding merchandise as a prize;
 \$20.00 per \$1,000.00 or part thereof of the retail value of the awarded prize(s);
- C. Non-Draw Raffles: Carnival Wheels and Games; \$20.00 for each wheel or game conducted on any day of series of six (6) consecutive days in one week;
- D. Off-Premise Draw Raffles: Awarding cash as a prize (50/50); \$20.00 per \$1,000.00 or part thereof of the retail value of the awarded prize(s); and

E. Bingo:

\$20.00 for each occasion.

Fees for Bingo licenses and Raffles licenses in categories A, B and C above are due in full at the time the application is filed with the Township. For raffle licenses in category D., a \$20.00 fee is due at the time the application is filed; and, if the awarded prize(s) exceeds \$1,000.00 an additional fee of \$20.00 per \$1,000.00 or part thereof awarded as a prize is due upon filing of the Report of Operation.

Section 2. Section 125-4. of the Code of the Township of Hanover is hereby amended and supplemented with the inclusion of the following year 2016 Swimming Pool Membership Fees for Residents and Non-Residents who pay prior to April 22, 2016 and after April 22, 2016 as follows:

<u>Section 6.</u> The governing body hereby authorizes the Department of Recreation and Park Administration to host an "End of Season – One Day Pass" promotional for residents only to utilize the Bee Meadow Swimming Pool on a daily basis, at a cost of \$10.00 per day for the period beginning August 19, 2016 and ending on September 5, 2016.

Section 7. If a current resident or non-resident pool member refers a new resident or non-resident to join the pool based on the membership categories described in Section 1. above, the resident or non-resident pool member making the referral shall receive a refund of 15% on the type of membership referral. The refund will be made at the conclusion of the pool season. However, the refund shall not exceed the cost of their original membership. The following charts show the refunds that would be made to each resident and non-resident pool membership for making a referral:

ORDINANCE NO. 5-2016

AN ORDINANCE AUTHORIZING THE EXECUTION OF A LEASE AGREEMENT WITH THE HANOVER TOWNSHIP LITTLE LEAGUE, INCORPORATED FOR THE OPERATION OF THE BLACK BROOK PARK CONCESSION STAND COMMENCING APRIL 23, 2016 THROUGH AUGUST 31, 2016

WHEREAS, the Hanover Township Little League, Incorporated is a

nonprofit organization which has requested permission from the Board of Recreation Commissioners and the Township Committee to operate the Black Brook Park Concession for the benefit of the public generally during the 2016 Little League Baseball season which begins on April 23, 2016; and

WHEREAS, the **Hanover Township Little League, Incorporated** agrees to comply with the Township's Specification which sets forth in full the standards and criteria for the proper operation of the Black Brook Park Concession Stand; and

WHEREAS, the Township Committee of the Township of Hanover believes it to be in the public interest that a lease agreement for ONE (\$1.00) DOLLAR be entered into with the **Hanover Township Little League, Incorporated** upon commencement of the baseball season on April 23, 2016 through August 31, 2016.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hanover, Morris County, New Jersey, as follows:

SECTION 1. The Mayor and Township Clerk are hereby authorized to enter into a lease agreement, a copy of which is attached hereto and made a part of this Ordinance, with the **Hanover Township Little League, Incorporated**, a nonprofit organization, for the nominal sum of ONE (\$1.00) DOLLAR commencing on April 23, 2016 through August 31, 2016 for the purpose of having the **Hanover Township Little League, Incorporated** operate the concession stand at Black Brook Park in serving the public generally.

SECTION 2. The Superintendent of Parks and Recreation is hereby designated as the officer of the Township to enforce the operational terms of the Lease Agreement.

<u>SECTION 3.</u> Prior to the inception of the lease, the **Hanover Township Little League**, **Incorporated** shall submit to the Hanover Township Business Administrator, proof of continuance of the tax-exempt status of the said non-profit organization pursuant to both State and Federal law.

SECTION 4. This ordinance shall take effect in accordance with law.

The Ordinance will be further considered for Public Hearing and Final Passage at the February 11th, 2016 meeting of the governing body and at time any person wishing to be heard will be given the opportunity to speak. The Ordinance and the Notice of Introduction will be published in full in the Daily Record in accordance with the law.

WHEREAS, by email dated January 19, 2016, the Chairman of EDAC advised the Business Administrator that following consultation with the members of EDAC, he was recommending that **Daniel Bonilla**, an Alternate 3 EDAC member be elevated an appointed as a regular member to fill the seat vacated by Mr. Nardone; and

WHEREAS, Committeeman and Deputy Mayor John L. Ferramosca, serving in his capacity as Liaison to EDAC endorses the recommendation to elevate **Daniel Bonilla** to serve as a regular member of EDAC; and

WHEREAS, pursuant to the provisions set forth under Chapter 21 of the Code of the Township entitled <u>Economic Development Advisory Committee</u>, specifically Sections 21-2.A. and 21-2.E. related to membership and terms of office, it is the intention of the Township Committee to elevate Alternate 3 member **Daniel Bonilla** to serve as a regular member for a two (2) year term of office expiring on December 31, 2017.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

A RESOLUTION OF THE TOWNSHIP COMMITTEE AUTHORIZING CHANGE ORDER NO. 1 (FINAL) TO TOPLINE CONSTRUCTION CORPORATION FOR THE RESURFACING OF THE ENTIRE LENGTH OF GRIFFITH DRIVE IN WHIPPANY AND DECREASING THE TOTAL DOLLAR AMOUNT OF THE CONTRACT FROM \$248,150.16 TO \$243,665.49 OR A \$4,484.67 REDUCTION WHICH REPRESENTS A 1.81% DECREASE OF THE TOTAL CONTRACT DOLLAR AMOUNT

WHEREAS, the Township of Hanover entered into a contract with **Topline Construction Corporation** for the resurfacing of the entire length of Griffith Drive in the Whippany Section of Hanover Township; and

WHEREAS, the amount of the competitively bid contract was a unit price bid totaling \$248,150.16; and

WHEREAS, the Township Engineer has submitted Change Order No. 1 (Final), dated December 10, 2015, which describes both extra work in the amount of \$28,436.78 and reductions in price totaling \$32,921.45; and

WHEREAS, the Township's Change Order No. 1 (Final) signed by the Township Engineer is attached hereto and made a part of this resolution as if set forth in full; and

WHEREAS, the Township Engineer has now determined that the reduced quantities for items needed in the resurfacing of the entire length of Griffith Drive shall decrease the total contract amount from \$248,150.16 to \$243,665.49 or a 1.81% decrease in the total dollar amount of the adjusted contract.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

- 1. The governing body approves the recommendation of the Township Engineer that Change Order No. 1 (Final), reducing the total contract amount by \$4,484.67 be accepted, and
- 2. That the final total adjusted contract amount with **Topline Construction Corporation** be fixed at \$243,665.49.
- 3. The Business Administrator/Township Clerk is hereby authorized to execute the final Change Order, Change Order No. 1.

Mr. Gallagher: I just want to acknowledge the DPW on the way they handled this last storm. I was in touch with Brian Foran for about 27 ½ straight hours. He actually texted me at 2:40 am to ask me how I was making out, I was at FDU, two minutes later I posted on Facebook that the Hanover Township DPW is still out in full force working hard and at 2:42 am people were responding to it. I know what these guys did in 27 1/2 hours I was driving home and I was exhausted and they weren't even tired yet, they were great, they did a great job cleaning up. Once again, Hanover Township PD was all over the place all the time, fantastic great example of what Hanover Township is all about.

The last thing I would say about the storm, what John said too, we all shared different things on Facebook, it's very important to shovel out your fire hydrant, because it's not just the fire hydrant for your house it's the fire hydrant for many houses in that area, and some people told me that they can't find it, well I said what if the men can't find it at 1:30 in the morning? So whatever it takes, find the hydrant that would be helpful to us and the Fire Department.

Lastly, I want to say is tomorrow night is week four for Hanover Township Youth take over Mennen Arena, the Mayor was there with me last week. We've had nice crowds up there a lot of people coming out. On February 12th, we are having two events at the same time, Sharon's Studio of Dance and Music is bringing their break dancers, older dancers to come and dance, it's going to be a good night, and the one thing I said at the Rotary I said, I let a lot of Political caroms and the one I always thought was pretty clever was when Bill Clinton referred to the Bridge to the 21st century, well what the Rec and the Substance Awareness Council it seems like we are trying to create a bridge to the Spring time and we are keeping these kids busy. Once we get done with our 8 weeks with Mennen Arena it will be spring time then baseball and we can have Bob tell us when the pool is going to be open.

Mayor: The Mennen program by the way is tremendous success, having witnessed with myself dozens and dozens of youngsters having a great time on the ice and

Mr. Giorgio: 76 children.

Mayor: Wow 76 that's fantastic, it was just very fulfilling to sit there and watch the kids enjoy themselves on Saturday night.

Punctuate the comment from Deputy Mayor Ferramosca on the snow, now only did our DPW do a continuation of plowing 30 something straight hours on our streets and got them cleared, by the way I have heard from other people traveling to other municipalities they said Hanover was a blessing and we do thank them for a wonderful job, but right after that, they got home and watched the Panthers and then Denver and then they were back out again opening up the intersections for all of our critical corners for buses, etc., so Brian and the group you guys did a wonderful job, and we do appreciate it, the whole town appreciates it.

For our neighbors, I got a lot of calls and concerns about sidewalk clearing, and the most of the people were very concerned on the enforcement that we would issue fines on sidewalks, we have explained to the best we can to the community, this was a tremendous storm and we relieved you of the immediacy of having to clean your sidewalks, but that does not mean we relieved you from cleaning your sidewalks, so do make preparation if you have not already, I know we have a lot of snow birds, a lot of people way, etc., you should have made that preparation before leaving for storms of that nature, to have the sidewalks cleaned and we ask your cooperation, we are trying to work with you and the sidewalks for the safety of our school age children and pedestrians that have to walk must be cleaned at some point.
