

ORDINANCE NO. 15-12

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER AMENDING AND SUPPLEMENTING ORDINANCE NO. 3-12 AND SECTION 125-4. ENTITLED "RECREATION DEPARTMENT FEES". UNDER CHAPTER 125 OF THE CODE OF THE TOWNSHIP OF HANOVER ENTITLED FEES WITH THE INCLUSION OF NEW RESIDENT AND NON-RESIDENT REDUCED POOL MEMBERSHIP FEES FOR THE YEAR 2012 BEE MEADOW SWIMMING POOL SEASON

WHEREAS, in a memorandum dated June 20, 2012 to the Mayor and Township Committee, the Board of Recreation Commissioners have recommended reduced pool fees for persons interested in obtaining membership at the Bee Meadow Swimming Pool for the period beginning August 1, 2012 through September 3, 2012; and

WHEREAS, the Township Committee has carefully reviewed the recommended fees and concurs that the proposed reduced fees are reasonable and fair and should be adopted for the balance of the Bee Meadow Swimming Pool Season.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

Section 1. Ordinance No. 3-12 and Section 125-4. Entitled "Recreation Department Fees". Under Chapter 125 of the Code of the Township entitled Fees is hereby amended and supplemented with the inclusion of reduced resident and non-resident pool membership fees for the balance of the Bee Meadow Swimming Pool Season beginning on August 1, 2012 and ending September 3, 2012 as follows:
