

ORDINANCE NO. 21-13

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER REPEALING SECTION 8, ENTITLED “DEFINITION OF PART-TIME EMPLOYMENT.” CONTAINED IN SALARY ORDINANCE NO. 15-13

WHEREAS, on July 2, 2013, the United States Department of the Treasury announced that there would be a one-year implementation delay concerning the employer mandate provisions of the Patient Protection and Affordable Care Act of 2010 as it relates to reporting requirements, employer owed penalties and providing affordable health benefits to full-time employees; and

WHEREAS, as a result of the delay, the Township Committee has decided to repeal Section 8, entitled “Definition of Part-Time Employment.” Adopted as part of Salary Ordinance No. 15-13 which provision reduces to twenty-eight (28) hours or less, the number of hours a permanent part-time worker of the Township can work in any week with respect to any month, and less than 130 total hours with respect to any month starting July 1, 2013.

NOW, THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

Section 1. Section 8. Entitled “Definition of Part-Time Employment.” as set forth in Salary Ordinance No. 15-13 is hereby repealed in its entirety. The repeal of Section 8. shall not affect any other provision adopted in Salary Ordinance No. 15-13.

Section 2. In case, for any reason, any section or provision of this Ordinance shall be held to be unconstitutional or invalid, the same shall not affect any other section or provision of this Ordinance or Salary Ordinance No. 15-13, except so far as the section or provision so declared unconstitutional or invalid shall be severed from the remainder or any portion thereof.

Section 3. All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, hereby repealed.

Section 4. This ordinance shall take effect in accordance with the law.
