

ORDINANCE NO. 30-13

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER AUTHORIZING THE RESURFACING OF MELANIE LANE FROM ITS INTERSECTION WITH ALGONQUIN PARKWAY TO THE BORDER OF EAST HANOVER TOWNSHIP WITHIN THE TOWNSHIP AND APPROPRIATING THE SUM OF \$270,000.00 FOR SAID IMPROVEMENT FROM THE NEW JERSEY TRANSPORTATION TRUST FUND AUTHORITY ACT AND THE YEAR 2013 CURRENT FUND BUDGET

WHEREAS, it is the intention of the Township of Hanover to resurface Melanie Lane from its intersection with Algonquin Parkway to the border of East Hanover Township in the Whippany section of the Township of Hanover; and

WHEREAS, due to its deteriorating condition, and in order to ensure the safety of pedestrians and motorists, it is the desire of the Township Committee to resurface Melanie Lane; and

WHEREAS, funds for the resurfacing of Melanie Lane will be made available through the Road Construction and Reconstruction Account of the Township's calendar year 2013 Current Fund Budget, and a grant from the New Jersey Department of Transportation's fiscal year 2013 Municipal Aid Program; and

WHEREAS, the resurfacing of a portion of Melanie Lane will include milling, new asphalt riding surface, drainage modifications, and other related improvements as specified in the Township's Specifications and Supplementary Specifications.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

Section 1. The resurfacing of Melanie Lane from its intersection with Algonquin Parkway to the East Hanover Township border is hereby authorized, all in accordance with the Specifications and Supplementary Specifications prepared by the

Township Engineer, and dated August, 2013. The resurfacing project shall include milling, new asphalt riding surface, drainage modifications, and other related improvements. The Township Engineer is further authorized and directed to publicly advertise for the receipt of sealed competitive bids pursuant to the Local Public Contracts Law at N.J.S.A. 40A:11-1 et seq.

Section 2. There is hereby appropriated for the purposes set forth in Section 1. of the Ordinance, the sum of \$270,000.00 from the following accounts set forth below:

1. The New Jersey Department of Transportation's
Fiscal Year 2013 Municipal Aid Program.....\$145,000.00

2. Year 2013 Current Fund Budget -
Road Construction & Reconstruction
Account, Account No. 0048.....\$125,000.00

- TOTAL.....\$270,000.00**

Section 3. This Ordinance shall take effect in accordance with law.
