

ORDINANCE NO. 16-2014

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER IN THE COUNTY OF MORRIS AUTHORIZING THE PURCHASE OF ONE (1) NEW PASSENGER BUS WITH TWELVE (12) AMBULATORY SEATS AND ACCESSIBILITY FOR TWO (2) WHEELCHAIRS FROM THE WOLFINGTON BODY COMPANY PURSUANT TO CONTRACT NO. CC-9012-13 AWARDED BY THE SOMERSET COUNTY COOPERATIVE PRICING COUNCIL AND FURTHER APPROPRIATING THE SUM OF \$55,000.00 FROM THE CAPITAL IMPROVEMENT FUND OF 2014 AND ALL PRIOR YEARS FOR THE PURCHASE OF THE PASSENGER BUS

WHEREAS, through the Township's Recreation and Park Administration Department, the Township operates a Dial-A-Ride Program providing transportation services to its senior citizens; and

WHEREAS, a need exists to replace a 1996 Dodge Ram 3500 Dial-A-Ride Van that has outlived its useful purpose; and

WHEREAS, the Superintendent of the Recreation and Park Administration Department has recommended that the Township Committee authorize the purchase of one (1) new passenger bus with twelve (12) ambulatory seats and accessibility for two (2) wheelchairs; and

WHEREAS, it is the intention of the Township Committee to authorize the replacement of the 1996 Dodge Ram with the purchase of a new passenger bus for the Township's Dial-A-Ride Program.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:


Section 1. There is hereby authorized the purchase and acquisition of one (1) new passenger bus with twelve (12) ambulatory seats and accessibility for two (2) wheelchairs to be assigned to the Township's Dial-A-Ride Program. The passenger bus shall be purchased from **Wolfington Body Company** located at 1315 Route 38, P.O. Box 160 in Mount Holly, New Jersey 08060 pursuant to Contract No. CC-9012-13 authorized and awarded through the Somerset County Cooperative Pricing Council.

Section 2. There is hereby appropriated from the Capital Improvement Fund of 2014 and all prior years, the sum of \$55,000.00 for the purchase of the new wheelchair accessible passenger bus described in Section 1. Of this Ordinance.


Section 3. This Ordinance shall take effect in accordance with law.


