

ORDINANCE NO. 18-2014

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER IN THE COUNTY OF MORRIS AMENDING AND SUPPLEMENTING SECTION 125-4. ENTITLED "RECREATION DEPARTMENT FEES." AND THE CREATION OF A NEW SECTION 125-9.H.(8) UNDER "FEES APPLICABLE TO ACCIDENTS AND INCIDENT REPORTS." TO BE INCLUDED IN CHAPTER 125 OF THE CODE OF THE TOWNSHIP ENTITLED FEES

WHEREAS, the Hanover Township Multi-Purpose Community Center located at 15 North Jefferson Road and Monroe Hall located at 324 Whippany Road are utilized by Township residents and Township based community groups, organizations and corporations in sponsoring a variety of events, programs and activities; and

WHEREAS, in order to monitor such community events, the Township's Recreation and Park Administration Department is required to assign a proctor during the use of either facility; and

WHEREAS, the Board of Recreation Commissioners has recommended that the Township Committee establish a \$15.00 per hour proctor fee that would cover the cost of a proctor assigned to monitor an event or activity; and

WHEREAS, it is the intention of the Township Committee to amend and supplement Section 125-4 entitled "Recreation Department Fees." under Chapter 125 of the Code of the Township by including a \$15.00 per hour proctor fee; and

WHEREAS, it is also the intention of the Township Committee to amend and supplement Section 125-9.H.(4) entitled "Fees Applicable to Accidents and Incident Reports." Also under Chapter 125 of the Code of the Township to include the fee a person must pay when requesting an accident report through the CarFax: Law Enforcement Solutions Program in which the Township participates.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

Section 1. Section 125-4. Entitled "Recreation Department Fees." Is hereby amended and supplemented with the inclusion of the following:

"Community Center and Monroe Hall Proctor Fee: Whenever a resident or Township based group, organization or corporation sponsors an event at the Township's Multi-Purpose Community Center or Monroe Hall, that resident, group, organization or corporation shall pay a \$15.00 per hour Proctor fee in underwriting the cost of a Proctor (which fee includes the Township's administrative costs) who is responsible in opening and closing the facility as well as monitoring the event or activity."

Section 2. Section 125-9.(H). entitled "Fees Applicable to Accidents and Incident Report." Is hereby amended and supplemented with the creation of a new subparagraph (8) to read as follows:

"Two (2) Dollars for accident reports only requested through the CarFax: Law Enforcement Solutions Police Crash Assistance Program through which the Township participates, pursuant to N.J.S.A. 39:4-131."


Section 3. In case, for any reason, any section or provision of this Ordinance shall be held to be unconstitutional or invalid, the same shall not affect any other section or provision of this Ordinance, except so far as the section or provision so declared unconstitutional or invalid shall be severed from the remainder or any portion thereof.

Section 4. All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, hereby repealed.

Section 5. This ordinance shall take effect in accordance with the law.


