## **ORDINANCE BH1-2015**

"AN ORDINANCE TO AMEND CHAPTER 284 "FEES" OF THE CODE OF THE TOWNSHIP OF HANOVER BOARD OF HEALTH, TOWNSHIP OF HANOVER, COUNTY OF MORRIS"

**WHEREAS** the Township of Hanover Board of Health believes that it must periodically review the fees it charges for various services to assure that they accurately reflect the cost to the Township for those services; and

**WHEREAS** the Township of Hanover Board of Health, after a careful review, believes that the current fee schedule must be adjusted to accurately reflect the cost to the Township for the respected activities; and

**WHEREAS** it is the desire of the Township of Hanover Board of Health to amend certain fees to more accurately reflect the current trends and costs to the Township;

**NOW, THEREFORE, BE IT ORDAINED**, by the Board of Health of the Township of Hanover, County of Morris, as follows:
