## **ORDINANCE NO. 21-2015**

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER AMENDING AND SUPPLEMENTING THE JOB CLASSIFICATION GUIDE KNOWN AS SCHEDULE "B" AS SET FORTH IN SALARY ORDINANCE NO. 10-2015 WITH THE INCLUSION OF A NEW JOB POSITION TITLE OF FULL-TIME ENGINEER/CAD OPERATOR UNDER JOB GROUP IX

WHEREAS, the Engineering Department seeks to employ a full-time Engineer/CAD Operator who will assist the Township Engineer and Assistant Township Engineer with the design, management and inspection of various infrastructure projects including the need to utilize various computer software in the performance of technical engineering functions; and

WHEREAS, a need exists to amend and supplement the Job
Classification Guide known as Schedule "B" as set forth in Salary Ordinance No. 102015 with the inclusion of a new job position title of Full-Time Engineer/CAD Operator.

**NOW, THEREFORE, BE IT RESOLVED,** by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

<u>Section 1.</u> Section 9. of Salary Ordinance No. 10-2015 entitled Schedule "B", the Job Classification Guide which lists various job position titles is hereby amended and supplemented with the inclusion of the following new job position title under Job Group IX:

## "Full-Time Engineer/CAD Operator"

<u>Section 2.</u> All ordinances or parts of ordinances in conflict or inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, hereby repealed.

Section 3. If for any reason, any section or provision of this Ordinance shall be held to be unconstitutional or invalid, the same shall not affect any other section or provision of this Ordinance, except so far as the section or provision so declared unconstitutional or invalid shall be severed from the remainder or any portion thereof.

Section 4. This ordinance shall take effect in accordance with the law.
