

ORDINANCE NO. 40-2018

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY AUTHORIZING THE PURCHASE AND INSTALLATION OF A PAVILION FOR THE STONEY BROOK COMMUNITY FARM AND GARDEN AND FURTHER APPROPRIATING THE SUM OF \$25,000.00 FROM THE TOWNSHIP'S 2018 CURRENT FUND BUDGET FOR THE FINANCING OF THE PROJECT

WHEREAS, the Township created a Community Farm and Garden to permit residents to grow fresh local produce for themselves and provide fresh vegetables to community food pantries for distribution to those in need; and

WHEREAS, the Township has been working with the Hanover Township Board of Education to provide a learning experience for students for the purpose of increasing awareness of plant sciences, sustainability, nutrition and health outside of the classroom environment at the garden; and

WHEREAS, a need exists at the garden to provide shelter from the elements for both gardeners and students in hot or inclement weather conditions; and

WHEREAS, it is the intention of the Township Committee to authorize the purchase and installation of a pavilion for the purpose of providing shelter to gardeners and students.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Hanover, in the County of Morris and State of New Jersey as follows:

Section 1. The governing body hereby authorizes and approves the following capital improvement for the Stoney Brook Community Farm and Garden:

1. The purchase and installation of a pavilion complete with foundation.

Section 2. The Township Engineer and/or the Assistant Township Engineer are authorized and directed to retain the services of a licensed professional engineer in order to prepare the necessary drawings, plans and specifications for the construction of the pavilion and foundation.

Section 3. In accordance with the drawings, plans and specifications to be prepared by the licensed professional engineer, the Township Engineer and/or Assistant Township Engineer are authorized and directed to obtain at least two (2)

written competitive quotations for the construction of the pavilion and foundation, all in accordance with the requirements of the Local Public Contracts Law at N.J.S.A. 11-6.1.

Section 4. There is hereby appropriated the sum of \$25,000.00 to furnish and install the improvements as described in Section 1. of this Ordinance from the following account:

1. Year 2018 Current Fund Budget
Improvements to Public Buildings and Grounds

Section 5. All ordinances of the Township of Hanover, which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 6. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this ordinance.

Section 7. This Ordinance shall take effect in accordance with law.
